SUPPLYING AND INSTALLATION OF BOREHOLE PUMP AND ASSOCIATED PIPEWORK AND SWITCHGEAR

The Overberg District Municipality invites tenders for the complete supply and installation of a borehole pump with associated pipework and switchgear at the Karwyderskraal Landfill located between Botrivier and Hermanus. The work includes the supply of all material and equipment and the installation thereof.

Documents, in English, are obtainable at the offices of the Overberg District Municipality, Supply Chain Management Unit, Recreation Street, Bredasdorp. Sealed tenders, with “**Tender No. T15-2021/2022: Supplying and Installation of Borehole Pump and associated Pipework and Switchgear**” clearly endorsed on the envelope, must be delivered to Overberg District Municipality, 26 Longstreet, Bredasdorp prior to the closing date and time for receipt of tenders at **12:00 on Monday, 14 February 2022** and will be opened as soon as possible thereafter. Tenders submitted by fax, email, or received after the closing time and date shall not be accepted.

Tenders must be valid for ninety (90) days after the closing date.

Bidders should have an estimated CIDB contractor grading of **1** or higher **in the CE, ME, EP or EB** class of construction.

A **compulsory briefing session** will be held at **11h00** on **Wednesday, 26 January 2022**, virtually via the **Microsoft Teams** application. Tenderers must register for the compulsory clarification meeting by sending their contact details (telephone and email address) to Ms C Reid (creid@odm.org.za) **by no later** than 21 January 2022 at 12h00, in order to receive the invitation link via email.

Overberg District Municipality shall apply its Municipal Supply Chain Management Policy as adopted in terms of section 111 of the Local Government Municipal Finance Management Act, 2003 (Act No 56 of 2003) and the relevant regulations. Tenders will be evaluated according to the criteria and weight of the 80/20 preferential procurement system. **Bidders must submit a valid Tax Clearance Certificate issued by the South African Revenue Services.**

IMPORTANT NOTICE: This tender is subject to Regulation 8 “Local Production and Content” of the Preferential Procurement Policy Framework Act, 2000: Preferential Procurement Regulations, 2017 (No. R.32 dated 20 January 2017). Submitting of the MBD 6.2 and applicable annexures are compulsory. Bidders must achieve the minimum local content for Steel Products and Components for Construction. The stipulated minimum threshold(s) for Local Production and Content for this bid is/are as follows:

- **Pumps, medium voltage (MV) Motors and associate accessories 70%**
- **Electrical cable products 90%**
- **Steel conveyance pipes, pipe fittings and specials 100%**

It is the prerogative of the municipality not to accept the lowest, a part of or any tender at all.
