### **NOTICE IN TERMS OF SECTION 116(3)(b) OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, 2003 (ACT 56 OF 2003) FOR THE AMENDMENT TO THE EXISTING APPOINTMENT OF GROUP 9 SECURITY ACTIVITIES CC t/a GROUP NINE SECURITY FOR THE AWARDED TENDER T05-2018/19 LEASING OF BUILDING AND OPEN AREA FOR A LAUNDROMAT AT UILENKRAALSMOND RESORT**

Notice is hereby given in terms of Section 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) that it is the intention of the Overberg District Municipality to amend the existing contract:

**Number:** T05-2018/19

**Description:** Amendment to the existing appointment of Group 9 Security Activities CC t/a Group Nine Security for the awarded tender T05-2018/19 for the Leasing of Building and Open Area for a Laundromat at Uilenkraalsmond Resort

#### **Reasons for the proposed amendment:**

The contract has been awarded for a period of three years. The Overberg District Municipality intends to extend the contract for a further period of twelve months on a month-to-month basis on the same terms and conditions as the current contract.

Due to the pandemic and the state of disaster restrictions that were/is in place, the current contractor, could not for large periods during the lease do business from the leased facility. This constituted a huge financial loss to the contractor.

The current appointed service provider has established a valuable relationship with all affected parties and the service rendered from the leased contributes to the popularity of the resort.

Notice is hereby further given in terms of Section 21 and 21A of the Local Government Municipal Systems Act, 2000 (Act 32 of 2000) that the local community and affected parties are invited to submit comments or representations on the proposed amendment of agreement. Such comments or representations must be submitted by not later than Friday, 28 January 2022 at 12:00.
